Background information on SCHIFF-MARTINI & CIE. GmbH

The auditing and tax advisory firm Schiff-Martini & Cie. GmbH (SMC) was founded in February 1992. The core of its advisory services is to support German subsidiaries of foreign investors with a complete package of services, which in addition to auditing, accounting and tax advisory services also covers staff recruitment and site identification for the subsidiary concerned.

The core of its consultancy work is support for German subsidiaries of foreign investors with a complete package of services: from start-up consultancy covering the legal and tax structuring, accounting, payroll and compliance, tax consultancy, M&A transaction consultancy, all the way through to support with cooperation partners in site identification, staff recruitment, notary services, legal and business management consultancy, plus insurance services, visas and work permits.

SMC, as an internationally focused firm of consultants, currently supports around 300 German subsidiaries with investors from a total of 20 different countries. More than 75 per cent of the clients are headquartered in the USA, the UK or Japan. This means the regional focus of consultancy is on Asia, the USA and Europe. SMC's 70-strong crew is correspondingly international in composition, including a dedicated team for Japanese clients featuring native-speakers.

The client portfolio essentially comprises sales companies, with some production enterprises as well. Over the course of the years, SMC has built up a fund of specialised expertise in the following sectors: property, automotive component suppliers, IT/software, the pharmaceutical and medical sectors, and the fashion industry. For the property sector, there is even a complete team.

The clients are usually mid-tier companies with a head count of roughly 500 employees. The sales volume will range up to one billion euros, depending on the client and the sector involved. The client base includes numerous enterprises listed on the stock exchange.

SMC is a member of BKR International (www.bkr.com), one of the world's leading alliances of independent tax consultants and auditors, numbering approximately 160 companies with 500 facilities in 80 different countries. In Germany, there are seven members.
